34. MATTERS ARISING FROM PREVIOUS MINUTES (information only)

- Mr Payne advised the meeting that the planning application F/YR09/0832/F variation of Condition 6 and removal of Condition 7 of planning permission F/YR08/0348/F to allow one way access into the site from the byway south of Beechings Close Playing Field Station Road, Wisbech St Mary was being discussed at the Planning meeting on Wednesday, 10th March 2010. As the Parish Council recommend approval and the police and representatives of the residents of Beechings Close are recommending refusal he asked whether the Parish Council should have a representative at this Planning meeting. Mr Parrin advised the meeting that Mr M Holmes was to attend this meeting to speak on behalf of the Community Centre. It was agreed that no representative from the Parish Council would attend.
- The clerk advised the meeting that she had not received a reply to her email regarding a representative from Fenland District Council attending all of our meetings.
- Mrs Thrower advised the meeting that she had completed an application for a grant for a general grant for the footpaths within the parish.

36. FDC NEIGHBOURHOOD COMMUNITY DEVELOPMENT OFFICER

- The half term activities had been well received with over 100 people attending the cinema sessions. They are in the process of working with Murrow Children's Centre to arrange activities for the Easter holidays.

40. HIGHWAYS AND LIGHTING MATTERS

- (a) Details from CPALC for a CCC Highways website for reporting pot holes www.fixmystreet.com. **Noted.**

Highways reports from Councillors on problems

1. Pot hole Plash Drove S Bends after The Chequers, Tholomas Drove.
2. Disabled ramp broken down by Elgoods Brewery lorries at the Black Hart, Thorney Toll. This was reported about three months ago and is a matter of Health and Safety as disabled residents have to travel on the road.
3. Church Road, Wisbech St Mary behind the fish shop road collapsing. A kerb needs to be installed to alleviate this problem.
4. Church Road, Wisbech St Mary near Mayfair Gardens and Sayers Field pot holes.
5. Road uneven in Gull Road, Guyhirn after Plash Drove and before the bowling green, Guyhirn side of Cants Drove.
6. Hedge needs cutting from Garden Lane to Humphreys Farm.
7. Front Road, Murrow pot hole in the middle of the road near the Chapel and the Bell Inn.
8. Front Road, Murrow pot hole near the Church.
9. Pot holes at The Pidgeons, Murrow.
10. Seadyke, Murrow subsidence of the side of the road.
11. Seadyke Murrow a very large pot hole end of Silvers Lane.
12. Seadyke, Murrow outside Bostons road water logged.
13. Pot holes at Bellamys Bridge.
14. More road signs at Bellamys Bridge.
15. Very uneven road Gull Road between Murrow and Guyhirn, particularly bad on either side of the junction of Cants Drove.
16. Gull Road Guyhirn, between Cants Drove and Guyhirn safety signs missing.
17. The leylandi hedge at Sheraden House, Guyhirn needs cutting as it obscuring the bus stop and also the pavement. It was agreed that the clerk writes stating that if is not cut within 28days we will have it cut and pass the invoice to them for payment.
18. Hedge needs cutting Sandbank, Wisbech St Mary after the houses to Bellamy's Bridge needs cutting.
19. End of Parnell Road oposit Black Drove drain blocked and road completely under water the whole width of road for about 12 metres.
20. Follleys Drove, Guyhirn the complete service of the road disappearing.
21. Pot hole at the top of Beechings Close, Wisbech St Mary.
22. Streetlight not working on the A47 at Thorney Toll on the bus stop lay by.

Mr Parrin stated that he is meeting with Mr Band on the 15th March to ride around the Parish to point out Highway matters.

It was suggested by Mr Payne that the clerk should be more assertive when reporting Highway matters to CCC Highways. It was agreed that Jill Tuck be advised of all Highway matters reported.

The Parish Council had agreed to cover the cost of this Insurance.**

44. **GUYHIRN PLAYING FIELD**

Reply from John Hooper FDC regarding the boundary. Normally in the case of an open ditch the presumption is that the boundary is to the centre unless evidenced otherwise. The other "normal" assumption is that where there is a hedge on one side the whole of the ditch will be owned by whoever owns the hedge. **After a discussion it was agreed that the Hedge be the boundary of the Playing Field.**

45. **NOTICE OF CASUAL VACANCY**

Letter from Fenland District Council Electoral Services Manager outlining the rules to fill the casual vacancy brought about by the resignation of Mr James Carney. **The clerk advised the meeting that the FDC Electoral Services had contacted her to state that they had not received any requests for an election and the Parish Council could now co-op.
