- Two residents of High Road, Wisbech St Mary asked for the Parish Councils support regarding an unauthorised caravan parked behind Poppy House.

- The clerk stated that she had reported the Highway matters to Councillor Tuck, but to date had not received any reply.

54. TO CONSIDER PLANNING APPLICATIONS RECEIVE

List of planning applications determined by the Fenland District Council.

- (a) F/YR10/0031/F erection of a 2 storey rear extension to existing dwelling involving part demolition at Cherry Cottage, Mouth Lane, Guyhirn. **Application withdrawn.**
- (b) F/YR10/0159/F siting of a mobile home and office and erection of 2no stables, chick nursery, chicken shed, glass house, 2 no poly tunnels and kennels/store Wayland Farm, Bevis Lane, Wisbech St Mary. Applicant Miss C Bartrum. Agent Mr N Lowe. **It was recommended that this be refused and to ask them to return the site to its original condition.**
- (c) F/YR10/0147/F erection of a 6 metre high piece of play equipment Playing Field and Pavilion Murrow Bank, Murrow. Applicant Murrow Playing Field Association. **We Support this development and recommend approval.**

55. CORRESPONDENCE RECEIVED

- (a) Norfolk Green Bus Service advising of new bus services and where information can be accessed. **The clerk advised the meeting that she had requested information leaflets, but to date they had not been received.**
- (b) CPALC regarding Future Jobs Fund. **Noted as this matter to be discussed under item 55d.**
- (c) Service change to Stagecoach services. **Noted.**

- (d) Future Jobs Fund Update. The Future Job Fund has been successful and Job Centre Plus is ready to deploy candidates to councils for interview. **At this point of the meeting Mr G Booth was asked to speak as Chairman of the Parson Drove Parish Council, who are the successful Parish Council for this scheme. The meeting was advised that the Job Centre had received 6 applications for this position to work 25 hours per week. This person would be deployed within Parson Drove and Wisbech St Mary Parish working 4 days for 6 hours per day carrying such duties as litter picking. After a discussion it was unanimously agreed that Mr D Thrower would join with Parson Drove on the Interview Panel. Once a selection had been made the successful applicant would have to be added to the Parish Council's Public Liability Insurance.**
- (e) Thank you Letter from Southea with Murrow and Parson Drove Parochial Church Council for the grant of £350.00. **Noted.**
- (f) Update from FDC regarding our nominated liaison officer Tim Mills. He will not be able to attend evening meeting until after July 2010. **Noted.**

56. HIGHWAYS AND LIGHTING MATTERS

(a) Update from CCC Highways regarding items passed to them from Parish Council meetings. **Mr Parrin met with Mr N Band from CCC Highways and toured the Parish. The matter of the hedge at Sheraden House, High Road, Guyhirn was discussed and that Highways would be writing to them. The clerk has written on several occasions. Mr Davies agreed to visit. An option open to the Parish Council is to place this matter in the Village Voices.**

Highways reports from Councillors on problems

1. Numerous pot holes at the top of Churchfield Road and Church Road, Wisbech St Mary.
2. Church Road, Wisbech St Mary behind the fish shop road collapsing. A kerb needs to be installed to alleviate this problem.
3. South side of Road between Bunkers Hill and Hoptoft subsiding.
4. Speed indicator in High Road, Guyhirn facing towards the pond and not the road.
5. Dog fouling in Church yard, High Road, Guyhirn.
6. Manhole inspection chamber in Tholomas Road is off. There is now a fence around it.
7. Footpath outside the bottle Bank at Guyhirn needs repairing.
8. Manhole covers rattle when cars drive over them in High Road, Guyhirn.
9. High curb outside chapel in Front Road, Murrow.
10. The Pidgeons, Murrow numerous pot holes where it joins Seadyke Bank and Front Road, Murrow.
11. Road collapsing from Walnut Cottage to the Church in Front Road, Murrow.
12. Pot holes in Seadyke Bank outside traveller site.
13. Numerous pot holes on the slip road Gull Road, Guyhirn
14. Very large pot hole in the middle of the road outside The Bell, Front Road, Murrow.
15. Mill Road, Murrow a large pot hole towards Murrow Bank.
16. Unauthorised car sales at The Firs, Gull Road, Guyhirn.

No Public Liability Insurance has yet been taken out as they are joining the PTCV organisation at a cost of £35 to enable them to purchase this Insurance at a reduced rate.**

60. **COMMUNITY FAIR AT WISBECH ST MARY 24.04.10.**

Discussion regarding a stand and a rota to enable the Parish Council to take part in this event.

Mr J Parrin agreed to attend the fair all day with other Councillors attending during the day. The clerk agreed to try and take photographs of different sites of the Parish to set up a display.

- Mr Parrin stated that he had been advised by the site manager that AWA will be sending out leaflets to households in Guyhirn at the end of March and that the sewerage system in Guyhirn should become active by the end of April.
- Mr Parrin stated that he had tried to get the rubbish bin outside the shop in Wisbech St Mary emptied more than once a week. It is emptied on a Thursday but it is overflowing by Monday. It was agreed that the clerk would try and get this bin emptied at least twice a week.
- Leaflets were distributed about the Fenland Handy Person Service.
